#### Board Discussion:

- Provide document from outside entity recognizing what the cost would be to utilize the property in each of the permitted uses of the Village Residential 1 Zone.
- Provide contract documentation with current owner
- Provide letter from current owner that authorizes applicant to submit Use Variance Application to ZBA.
- Provide documents to VH by August 22, 2022.
